Western Gas Resources Inc ('Western Gas') is managing the development of 8 wells in one Section at the Company's Esponda Project in the Powder River Basin. The Company reimburses Western Gas for its 25% working interest in this Section. During the June 2004 quarter, the Company paid \$106,000 (US\$77,000) to Western Gas out of a total expenditure by Western Gas of \$424,000 (US\$308,000).

Kennedy Oil is managing the development of, and sole funding, 12 wells at the Company's Esponda Project in the Powder River Basin to earn a working interest of approximately 75% of each well. Details of Kennedy Oil's expenditure during the June 2004 quarter have not been reported to the Company.
