Western Gas Resources Inc ('Western Gas') is managing the development of 8 wells in one Section at the Company's Esponda Project in the Powder River Basin. The Company reimburses Western Gas for its 25% working interest in this Section. During the December 2004 quarter, the Company paid \$47,850 (US\$35,340) to Western Gas out of a total expenditure by Western Gas of \$191,400 (US\$141,360).

Kennedy Oil is managing the development of, and sole funding, 12 wells at the Company's Esponda Project in the Powder River Basin to earn a working interest of approximately 60% of each well. Development expenditure made by Kennedy Oil to date is \$2,685,802 (US\$2,093,852), of which the Company's 40% carried share is \$1,074,321 (US\$837,541). Revenue from the sale of gas produced from the 12 wells will first be used to repay Kennedy Oil's development and operating costs.
