Western Gas Resources Inc ('Western Gas') is the operator of 9 wells at the Company's East Esponda Project in the Powder River Basin. The Company reimburses Western Gas for its 25% working interest in these wells. During the June 2007 quarter, the Company paid \$47,845 (US\$39,750) to Western Gas out of a total expenditure by Western Gas of \$191,380 (US\$159,000).

Western Gas also operates and sole funds 14 wells at the Company's East Esponda Project in the Powder River Basin to earn a working interest of approximately 60% of each well. Revenue from the sale of gas produced from these wells will first be used to repay the development and operating costs.
